## Emissions reduction targets

In order to continue our progress to achieving Net Zero by 2050, now we have calculated our emissions, we will set some interim reduction targets that will be documented in next year's Carbon Reduction Plan, linked to the carbon reduction initiatives we have in place.

## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

We have recently moved office space to a more energy efficient building. All staff use public transport to get to work, whereas previously many were driving to work. We don't use our allocated parking spaces.

### Current/Future Carbon Reduction Initiatives

We are intending to offer homeworking one day per week for all staff.

We will reduce the number of monitors/screens per staff member from 3 to 2, saving electricity usage.

We will also investigate all the options available for carbon offsetting schemes and will choose the most appropriate for us.

## Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
